### Information about us and how to contact us

### How we protect your personal information

The term **Data Protection Legislation** in the below refers to

1. For the purposes of the Data Protection Legislation, you, as the course participant, are the data controller and we are the data processor.

2. MEI will only use your personal information for matters that are essential in relation to the administration of the courses. It is likely that summary data will be collated for analysis of the impact of the courses. This data would not allow identification of any individual
3. A small administration team have access to site data. This team is obliged to keep personal data confidential in the Terms and Conditions for the courses. All data processing is compliant with the Data Protection Legislation
4. Unless it is required by Data Protection Legislation or any other applicable law, MEI will not share any course participant's personal data with any third party without the specific permission of that course participant.
5. MEI commits upon written instruction by a course participant, to delete or return personal data unless required by any applicable laws to store the personal data; and to delete personal data within 12 months of the course participant's Integral account ceasing to be active.
6. You consent to us appointing UKFAST <https://www.ukfast.co.uk> as a third-party processor of personal data incorporating terms which are substantially similar to those set out in this section.

### **Acceptable use of course resources**

1. Access to course resources provided to course participants is for their own personal use only.
